Affidavit of Probable Cause for Attempted Assault and Battery

- 1. Affiant can competently state the matters set forth herewith.
- 2. Affiant has personal knowledge of the facts stated herein.
- 3. All the facts stated herein are true, correct, and complete and not misleading, in accordance with Affiant's best firsthand personal knowledge and understanding.

Plain Statement of Facts

This is to inform the Rockland County Executive Ed Day
And all associated Health Department Officials
And the DCF of Rockland County:

THAT YOUR ACTIONS CONCERNING FORCED MEASLES, MMR OR OTHER VACCINATION OF myself OR MY CHILD AGAINST MY WILL OR BETTER JUDGMENT CONSTITUTES A PROBABLE CAUSE FOR ATTEMPTED ASSAULT AND BATTERY AND I INTEND TO PROSECUTE!

I intend to prosecute you for this action to the fullest extent of the law for the reasons provided:

1. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, are not bound by Title 18 USC, section 2381, where in the presence of two or more witnesses to the same overt act or in an open court of law, you fail to timely move to protect

- and defend the constitution of these united states, and honor your Oath of Office, you are subject to the charge of capitol felony treason.
- 2. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have the authority to dictate the meaning or interpretation of RELIGIOUS RIGHTS/FREEDOM under the united states constitution, or have the authority to dictate what is "for the greater good."

Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have the authority to violate any persons united states constitutional rights by any declared "state of emergency," which is not up for interpretation AND DEFENDED by precedent in court: **Marbury v. Madison**, 5 U.S. (1 Cranch) 137 (1803): **Marshall vs.Kansas City Mo.**, 355 S.W. 2nd, 877,883:

- 3. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have the authority to deny a person due process of law by forcing a medical treatment: Marshall vs.Kansas City Mo., 355 S.W. 2nd, 877,883: note 31, Breyers vs. United States 273 US 28
- 4. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have the authority to declare an emergency which strips away a persons free choice and will and intimidates them to succumb to unwanted and dangerous medical treatment:

Am. Jurisprudence. Section 98: Effect of public emergency;

"While an emergency cannot create power, and NO EMERGENCY JUSTIFIES THE VIOLATION OF ANY OF THE PROVISIONS OF THE UNITED STATES CONSTITUTION OR STATE CONSTITUTIONS "

Section 117:

The courts are not at liberty to search for meanings beyond the instrument of the constitution. The courts must apply the terms of the constitution as written.

Section 155:

The courts are not at liberty to overlook or disregard the constitutional demands. If the constitution prescribes one rule and the statute another, and a different rule, it is the duty of the courts to declare that the constitution and not the statute governs in cases before them for judgment.

Sections 255, 256:

An unconstitutional law is null and wholly void.

Sections 257, 258:

On the other hand, it is clear that congress cannot by authorization or ratification give the slightest effect to a state law or constitution which is in conflict with the constitution of the united states.

5. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have the authority to

- enforce medical treatment. Vaccination, especially a set of vaccinations, are considered a medical operation. I can not authorize such a procedure due to it's highly suspicious nature, and high chance of risk to my greater well-being, or the greater well-being of my child. The reasons for this are as follows: No vaccine can be deemed totally safe, since warnings of many symptoms and disorders arising from a vaccine can be found within the packet inserts of all vaccines the State requires by mandate.
- 6. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have assured me that by forcing vaccination is going NOT going to harm myself or my child.
- 7. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have the authority to compel me to succumb to forced vaccination when they as yet have not presented me with any personal guarantee, written or otherwise, that myself or my child will NOT be harmed by said vaccines the State has mandated.
- 8. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have the authority to make my comply with a medical procedure which has the possibility of creating autism, mental retardation, ADHD, decreased intelligence, cancer, disorders of the skin, allergies, disorders of the eyes and ears, sudden infant death syndrome, Parkinson's disease, dementia, Alzheimer's disease, respiratory and cardiac failure, chronic nervous system dysfunction, meningitis, encephalopathy, seizures, anemia, and epilepsy to name but a few.
- 9. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, have presented me with an assurance or guarantee that myself or my child will not acquire the diseases in which they claim to prevent.
- 10. Affiant has neither seen, nor been presented with, any evidence, and likewise any material fact, that demonstrates Rockland County Executive Ed Day, and all his associates enforcing FORCED VACCINATION, can declare that Since the majority of the population of Rockland County NY isvaccinated by their own choice for themselves and their children, if it is truly the position of the State that the vaccinations mandated do control the spread of the diseases they are given for, then my choice not to vaccinate myself or my child cannot possibly create an epidemic of any kind that poses a risk to the other citizens of the State.

I am of sound mind and body, and it is my firm philosophical belief that the said vaccinations mandated by the State of NY and Rockland County , have been proven by science to be extremely harmful to my body, or my child's body. Under this belief, and the belief that said mandated vaccinations will create harm to myself or my child, I hereby refuse such vaccines to be entered into my body or the body of my child without my permission and against my will.

I reserve all my constitutional rights, and my rights granted to me under the common law, and herby confirm that I will prosecute to the fullest extent of the law if these rights are violated in any way as a result of my decision not to vaccinate. If you continue to harass me about receiving or administering

such vaccinations against my will and better judgment, or if I or any member of my family are vaccinated by force due to any State vaccination statute or perception by any member of the DCF, I will fully prosecute Rockland County and Ed Day and any person who administers such a vaccine for assault and battery under the fullest extent of the law.
